MLA Citation Format

The paper should be double-spaced with a margin of 1 inch on all sides. There is no title page. The pages are numbered in the top right corner preceded by your last name. The first line of each paragraph is indented. References are on a separate page entitled Works Cited. The first line of each entry is flush with the margin, subsequent lines are indented. Italicize titles etc. as shown below. Alphabetize by the first word in each entry (usually the author's last name). Identify the source medium (Print., Web. etc.).

REMEMBER— if you use parenthetical citations (e.g. Anderson 7), the full citation information must appear in the Works Cited list.



Books:

No author:

Name of Book. Place of Publication: Publisher, Year Published. Print. One or two authors:

Author(s) [Last name, first name, (and first name last name)]. *Title of Book*. Place of Publication: Publisher, Year. Print.

Three or more authors:

First author, et al. (or names in full as they appear on the title page) *Title of Book*. Place of Publication: Publisher, Year. Print.

Books with a corporate or organization author:

Name of Corp./Organization. *Title*. Place of Publication: Publisher, Year. Print.

Anthology or Collection:

Last name, first name (of the editor), ed. *Title of Book*. Place of Pub.: Publisher, Year. Print.

Work in an Anthology:

Author. "Title of Article." *Title of Book*. Ed. Editor(s) name(s). Place of Publication: Publisher, Year. Page numbers (of entire piece). Print.



Articles:

From a Reference Book:

"Article Title." Name of Book. Edition. Year. Print.

From a Newspaper or Periodical:

Author. "Title of Article." *Title of Source*. Date (Day month abr. year in full): pages. Print.



Electronic Sources:

Websites:

Author (if available). Name of Resource. Date of Posting/Revision. Name of Institution/Organization affiliated with the site. Web. Date of access (day, month, year).

Article on a website:

Author (if available). "Article Name." Name of page. Date of posting/revision. Name of Institution/Organization affiliated with the site.
Web. Date of access.

Online data base:

Author(s). "Title of article." *Publication name*. Volume number. Date of publication: pages. *Name of database*. Service name. Library name, City, State. Web. Date of access.

Other Sources:

Interview by you:

Name of person interviewed (Last name, first name). (Personal or telephone). Date.

Encyclopedia:

Author of article (if given). "Article Title." *Title of book*. Edition. Place of publication: Publisher, Year. (Omit place of publication and publisher for well known encyclopedias)

Multi-volume Sets:

Author or editor. *Title of set*. Total number of volumes in set. Place published: Publisher, Medium. Year.

Videos, DVD, etc.

Title. Director, producer, and/or writer. Perf. Distributor, year. Format.

Tweet

Author last name, First name (twitter account name in parentheses). "Entire tweet inside quotation marks." date, time. Tweet.

Brokaw, Tom (tombrokaw). "SC demonstrated why all the debates are the engines of this campaign." 22 Jan. 2012, 3:06 a.m. Tweet.
